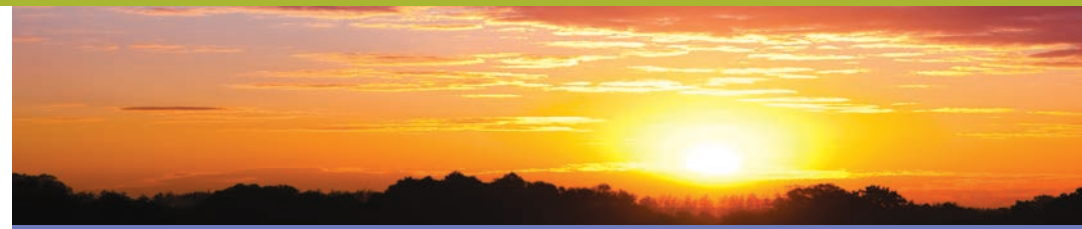

First in Houston, and then in Tulsa, OK, where her husband, Ed, had been transferred, Estha volunteered with the Juvenile Detention Center, the American Red Cross, and the American Heart Association. For twenty years, she devoted herself to the Presbyterian Church U.S.A., working with women's ministries to encourage women to be better leaders in their lives, in the church, in business and in their families. Estha had a special place in her heart for Native American women and found diversity, in all its forms, to be a cause for great celebration.

When her beloved Ed was cared for by a hospice in Tulsa, Estha volunteered there as well, in gratitude for the excellent care they received during Ed's illness. After Ed's death, Estha moved to Tyler to be closer to family and became acquainted with The Hospice of East Texas. What a privilege it was for The Hospice of East Texas to care for Estha in the last months of her life, sharing in her joy as the women she had mentored and encouraged in their lives, their spiritual journeys and their careers came to Tyler from all over the country to say good-bye.
